

**National Reining Horse Association  
2015 NRHyA Raffle Program  
Official Rules**

**1. HOW TO ENTER.** Purchase an NRHyA Raffle ticket from any NRHyA Member, NRHA Show Secretary or NRHA Staff and be entered for a chance to win.

Tickets are \$10 each. Every NRHyA Raffle booklet contains 20 tickets.

Entry must include entrant's name, physical address, city, state, zip code, NRHA Member Number (if applicable), home and/or cellular phone number.

No facsimiles, mechanical reproductions or alternate form of entries will be accepted.

**ALL ENTRIES MUST BE RECEIVED BEFORE THE DRAWING ON DECEMBER 5, 2015.**

**2. SCHEDULE.** Giveaway will be held during an arena drag at NRHA Futurity held on the Oklahoma City Fairgrounds on December 5th. The deadline to submit entries will be prior to the drawing that evening.

**3. DRAWING.** From among all eligible entries, winners will be selected by random drawing, to be held on or about December 5, 2015 during the NRHA Futurity Open Finals competition at the NRHA Futurity in Oklahoma City. The National Reining Horse Association and the Reining Horse Sports Foundation, whose decisions are final and binding in all respects, will conduct the drawing. By participating, entrants agree to be bound by the Official Rules, and the Sponsors' decisions. The drawing will consist of all eligible entries received. Winners will be contacted using the information on entry blank to select prizes in the order in which they were drawn. Winners who cannot be reached will be awarded the remaining prize after other winners have made selections. Winners need not be present at the Futurity but do need to provide transportation or shipping arrangements for all items upon leaving the Futurity.

**4. PRIZE, ODDS OF WINNING.** Winners will select from the available prizes in the order in which they were drawn. Prizes include 1 years supply of Platinum Performance Equine, 1 years supply of SmartSupplements from SmartPak, 1 Bob's Custom Saddle donated by Philip & Cora Solum, 1 year supply of jeans from Cinch or Cruel Girl, 1 Classic Equine Tack Package, 1 Kiser Edge Drag from Kiser Arena Specialist, and 1 Pairs of His & Her boots from Macie Bean and Anderson Bean Boot Company. **There is no prize substitution whatsoever. If the grand prize cannot be used for whatever reason by contest winner, it will be forfeited.**

Winners are solely responsible for all unspecified expenses associated with registering, claiming or using the prize, including but not limited to taxes, insurance, or other fees. Winners are not required to be present to win, but must secure transportation or shipping arrangements to home, ranch or facility.

Odds of winning depend upon number of eligible entries received. Winners will be notified by phone and/or by mail.

Entry is good only for person named thereon. The Prizes are non-assignable and nontransferable. No substitutions allowed. NRHA reserves the right to substitute an award of equal or greater value to the Prize.

**5. ELIGIBILITY.** Persons in any of the following categories are not eligible to participate or win the prizes: (a) persons who are employees of the National Reining Horse Association or Reining Horse Sports Foundation, or independent contractors of the above organizations; (b) persons who are engaged in the drawing of the winner for this Raffle; (c) persons who are immediate family of any person in either of the preceding categories.

Decisions of NRHA with respect to the Contest are final. NRHA reserves the right to amend, suspend or terminate the Contest at any time, which will become effective upon announcement. NRHA reserves the right, at its sole discretion, to disqualify any individual who (a) tampers with the entry process or the operation of the Contest; (b) attempts to forge an entry form or to otherwise submit a fraudulent prize claim; (c) acts in violation of the Official Rules; or (d) fails to fully comply with the directions of the Contest Officials.

**6. CONDITIONS OF PARTICIPATION.** Sponsor is not responsible for illegible, incomplete, late, lost, damaged, destroyed, delayed or misdirected entries, unintelligible or garbled entries. Once submitted, entries become the sole property of National Reining Horse Association and will not be returned. No substitution or cash equivalent of prize, except at the sole discretion of Sponsors due to prize unavailability for any reason and only then for a prize of equal or greater value. Winner will be required to sign and return an Affidavit of Eligibility, a Liability Release and a Publicity Release (where legal) within 10 days of contest ending date. If, for any reason, all required documents are not executed and returned within 10 days, such winner will be disqualified, with an alternate winner being selected. **Winners will be solely responsible for any and all applicable taxes associated with prizes.**

#### **United States Tax Requirements:**

Winners will be required to provide a properly completed and signed Internal Revenue Service (IRS) Form W-9 prior to receiving prizes. The winner will be issued by the RHSF a 1099-MISC for the fair market value of the prizes; the winner will be responsible to pay all applicable federal and state income taxes as a result of winning the Raffle Horse. Should winner refuse to provide the RHSF with a properly completed and signed IRS Form W-9, winner forfeits his or her right, interest, or title to the prizes. Winner may not assign his or her right to the award to another individual, RHSF will only provide the prizes to the winners, and only the winners will be issued Form 1099-MISC for the fair market value of the prizes.

Winners who are a Nonresident Alien for U.S. income tax purposes will be required to properly complete and sign Parts I & IV of Form W-8BEN: Certificate of Foreign Status of Beneficial Owner for United States Tax Withholding. Winners are subject to immediate IRS income tax withholding of 30% of the fair market value of the prizes, prior to the prizes being awarded to the winner, winner must pay to the RHSF in U.S. Funds 30% of the fair market value of the prize. RHSF will remit the tax payment (30% of fair market value) to the IRS and issue the winner an IRS Form 1042-S (Foreign Person's U.S. Source Income Subject to Withholding). Should winner refuse to properly complete or sign a Form W-8 BEN or pay the 30% withholding on the fair market value of the prize, winner permanently forfeits his or her right, interest, or title to the prize. Winner may not assign his or her right to the award to another individual, RHSF will only provide the prize to the winner, and only the winner will be issued a United States Federal Form 1042-S (Foreign Person's U.S. Source Income Subject to Withholding).

By participating, entrant (a) agrees to abide by and be bound by these Official Rules and the decisions of NRHA, which is final and binding in all respects; (b) releases and agrees to hold harmless National Reining Horse Association, Reining Horse Sports Foundation, Donors of the prizes, or their respective parent companies, affiliates and subsidiaries, officers, directors, shareholders, agents and employees from any and all liability whatsoever arising from entrant's participation in Contest or the acceptance, receipt, possession or use/misuse of any prize. By accepting prize, where permitted by law, winner grants (such grant to be confirmed in writing upon NRHA's request) to NRHA and NRHA's designees, the right to print, publish, broadcast and use, worldwide in any media now known or hereafter developed, including but not limited to the world wide web, at any time or times, the winner's name, portrait, picture, voice, likeness and biographical information as news or information and for advertising, trade and promotional purposes without additional consideration, and without further review, approval or notice. By accepting prize, winner further agrees, without such additional compensation, that winner shall appear for any presentation or other activity which may include filming/audio/video/electronic or other recordings and/or interviews, as may be determined from time to time by NRHA in its sole discretion. Notwithstanding foregoing, Winners agree that NRHA shall not be obligated to advertise or promote winner. As a condition of participating in the Contest, entrant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest shall be resolved individually, without resort to any form of class action, exclusively, before a court located in the City of Oklahoma City, Oklahoma County, Oklahoma, having competent jurisdiction, which Court shall apply the laws of the State of Oklahoma, without regard for doctrines of Conflict of Law of Oklahoma or any other jurisdiction.

**BY PARTICIPATING IN CONTEST, ENTRANT FURTHER WAIVES ANY RIGHT HE/SHE MAY HAVE TO A TRIAL BY JUDGE OR JURY.** Further, in any such dispute, under no circumstances will entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any

other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (that is, costs associated with entering this Contest), and entrant further waives all rights to have damages multiplied or increased.

Should any term in these Official Rules be deemed by a court of competent jurisdiction to be void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring this Section within the requirements of law, be deemed severed from the remainder of the terms in this Section, and the remainder of the Official Rules shall be given effect as if the severed term were not included herein.
